You and Untangle, Inc. ("Untangle") agree:

1. Definition of Contributions. The term "Your Contributions" means source code, object code, patches, tools, samples, graphics, specifications, manuals, documentation, or any other material submitted by You to the project.

2. You assign us the copyrights in Your Contributions and grant us the ability to use them in any way. You assign to Untangle all right, title and interest worldwide in all copyrights and related moral rights for the full term of their existence in and to Your Contributions. If the moral rights are not assignable, you agree to waive their enforcement against Untangle and its licensees, either direct or indirect. In addition, (a) to the extent that the foregoing assignment is void, ineffective, or unenforceable and/or (b) if You, now or in the future, have any patents or other worldwide intellectual property rights that would be infringed by use, reproduction, preparation of derivative works, public performance or display, distribution, or other exploitation in any manner of Your Contributions, You hereby grant to Untangle a non-exclusive, perpetual, irrevocable, worldwide, royalty free, transferable license under all worldwide intellectual property and proprietary rights to do any or all of the foregoing acts, with the right to sublicense all of these rights through multiple tiers of sublicensees. Untangle shall have the right to record this assignment

3. You may continue to use Your Contributions in any way. Untangle grants to You a non-exclusive, perpetual, irrevocable, worldwide, royalty free, transferable license, under all copyrights and moral rights assigned by You above, to use, reproduce, prepare derivative works of, publicly perform and display, distribute, and otherwise exploit in any manner Your Contributions, with the right to sublicense all of these rights through multiple tiers of sublicensees. The intention of the parties is that this license will be as broad as possible and to provide You with the rights as similar as possible to the rights of the owner of the assigned rights in Your Contributions. This license is limited to Your Contributions and does not provide any rights to the Untangle project.

4. You are able to grant us these rights. You represent that You are legally entitled to make the assignment and grant the license above. If Your employer has rights to intellectual property that You create, You represent that You have received permission to make the contributions above on behalf of that employer, or that Your employer has waived such rights for Your Contributions.

5. The Contributions are your original work. You represent that Your Contributions are Your original works of authorship and that You are legally entitled to grant the rights and privileges conveyed by this Agreement. You warrant that Your Contributions, to the best of Your knowledge, do not violate any other party's copyrights, trademarks, patents or other intellectual property rights.

6. We determine the code that is in our products. You understand that the decision to include Your Contributions in any product or source repository is entirely that of Untangle, and this agreement does not guarantee that Your Contributions will be included in any product.

This Agreement shall be governed by the laws of the State of California and applicable U.S. Federal law, without application of choice of law rules This Agreement constitutes the entire agreement between the parties
